- 1. Process Description for the proposed system.
- 2. Process flow diagram, with major equipment list to be indicated by the vendor.
- 3. Power / Fuel source arrangement with local suppliers in case the offer is on BOT/BOOT basis.
- 4. Plot area required
- 5. Name of Firm / Consortium / Joint Ventures including the name of leading firm and indicating individual experience of each firm in supply of Desalination plant facilities.
- 6. List of clients to whom facilities on similar basis or any other basis has been provided. Vendor should have executed at least one plant in the last 5-years. Vendor shall have experience of supply of minimum 3 such plants, with at least one plant having capacity similar to that required or higher.
- 7. Firm shall indicate the list of clients for which it is operating the desalination facilities on BOT / Boot basis. Firm shall submit the certificate from the user indicating the compliance of raw water quality as per agreed required specifications, quality of inlet sea water to the desalination unit, cost of raw water paid by the user. Vendor to indicate whether the cost raw of water matches to that agreed at the project stage or has there been an escalation.
- 8. Registration with state, Local or any other international standard statutory body / organization (if any)
- 9. Order of Magnitude cost with an accuracy of + 30% for the Desalination plant facilities for the specified quality of inlet seawater. The cost shall include, cost of intake system, RO system, permeate / saline water transfer system, and other utility systems.
- 10. Order of magnitude Cost of Desalinated water made available to the client in Rs/M3 for BOT/BOOT basis.
- 11. If the Firm offers the desalination plant facilities other than BOT/BOOT basis, vendor to indicate the reasons thereof.
- 12. The firm offering Desalination unit on BOT/BOOT basis shall locate their unit in the vicinity of Refinery.
- 13. The firm is required to obtain necessary statutory clearances required from the authorities concerned for the said facilities wherever they are sited. Vendor to provide write-up on the approach that would be taken for setting up the Desalination facilities on BOT/BOOT basis.
